

PERSONAL DATA PROCESSING AGREEMENT

1. General provisions

1.1 Personal data processing agreement (hereinafter referred to as the «Agreement») is aimed at the individuals' rights and freedoms rights protection, whose personal data are processed by Alexander S. Filipenko (hereinafter referred to as the «Information user»).

1.2 The Agreement was developed in accordance with the Law of the Republic of Belarus «On Information, Informatization and Information Protection» of 10.11.2008 No. 455-3 (hereinafter referred to as the «Law») and other legislative acts of the Republic of Belarus.

1.3 The current Agreement is a publicly available document.

2. The information user's data

2.1 The information user's data was registered on September 26, 2017 by the administration of the Oktyabrsky District of Mogilev in the Unified State Register of Legal Entities and Individual Entrepreneurs with the registration number 791105250.

2.2 The information user's legal address: 212002, Mogilyov, Alleynaya st, 1, 33 ap. The information user's actual address: 212002, Mogilyov, Alleynaya st, 1, ap. 33.

3. Personal data processing information

3.1 The personal data processing information user processes personal data in a lawful and fair manner in order to achieve legitimate goals, including the services provision and the information transfer to Personal Data Holders (hereinafter referred to as the «Client»).

3.2 Information User receives personal data directly from the Clients.

3.3 The information user processes personal data in automated and non-automated ways, both with and without using computer technology tools.

3.4 Personal data processing actions include the receipt, collection, processing, accumulation, storage and use.

4. Client's personal data processing

4.1 The Information User processes the Client's personal data within the legal relations with him in accordance with the legislation of the Republic of Belarus.

4.2 The Information User processes the Clients' personal data in compliance with the legislation of the Republic of Belarus in order to:

4.2.1 accept Clients' requests;

4.2.2 inform about new products, special promotions and offers;

4.2.3 newsletter;

4.2.4 Clients' location determination to ensure security and prevent fraud;

4.2.5 confirm the accuracy and completeness of personal data, provided by the Client.

4.3 The Information User processes the Clients' personal data with their consent, provided by the Clients and / or their legal representatives by performing specific actions on «www.strong-code.pro» website (hereinafter - the «Website»), including but not limited to, placing an order, subscribing to the newsletter, as well as putting a mark of consent, in accordance with the current Agreement.

4.4 The Information User processes the Clients' personal data no longer, than required by the personal data processing purposes, unless otherwise provided by the legislation of the Republic of Belarus.

4.5 The Information User may process the following Clients' personal data:

4.5.1 full name;

4.5.2 contact phone number;

4.5.3 email address.

5. Information on Clients' personal data security ensuring

5.1 The User takes the required legal, organizational and technical measures or ensures their adoption to protect personal data from unlawful or accidental access to them as well as personal data destruction, modification, blocking, copying, provision, dissemination and other illegal actions prevention, while processing personal data.

5.2 All the measures, intended to ensure the personal data security during their processing, used by the Information User, are planned and implemented in order to ensure compliance with the Law requirements, as well as other legislative acts of the Republic of Belarus.

6. Clients' rights

6.1 The Client is entitled to:

6.1.1 submit a request for the personal data provision, being used;

6.1.2 clarify (change) own personal data in case they are incomplete, outdated, inaccurate;

6.1.3 cancel own consent for his personal data processing;

6.1.4 protect own rights and legitimate interests, including compensation for damages, including moral damage in court;

6.1.5 to appeal against the Information User's actions or omissions to the authorized body for the consumer rights protection in the court.

6.2 The Client has the right to contact the Information User in the manner, prescribed by the legislation of the Republic of Belarus in order to implement own rights and legitimate interests.

7. Final provisions

7.1 The Agreement and the relationship between the Information User and the Client are governed and interpreted in accordance with the legislation of the Republic of Belarus. Issues, failed to be regulated by the Agreement, shall be resolved in accordance with the legislation of the Republic of Belarus.

7.2 The Agreement is a public offer, in accordance with Part 2 of Article 407 of the Civil Code of the Republic of Belarus. Full acceptance of the current Agreement terms is deemed the fact of putting a mark of consent with the content of the Agreement by the Client on the Website. Ignorance of the current Agreement provisions does not relieve the Client from liability for non-compliance with its terms.

7.3 The Information User is entitled to change and (or) supplement the current Agreement at any time in his sole discretion without prior and (or) subsequent notification of the Client. The current Agreement version is available on the Website.

7.4 The current Agreement comes into force with respect to each of the Clients from the moment the Client performs the actions, specified in the clause 7.2 of the current Agreement while being valid until the time, provided for in clause 6.1.3 of the current Agreement.
