PRIVACY POLICY

The current personal data Privacy Policy for (hereinafter referred to as the Privacy Policy) applies to all User's data, which www.strongcode.pro website may get during the website use.

1. TERMS DEFINITION

- 1.1. The following terms are used in the current Privacy Policy:
- 1.1.1. «Website» website <u>www.strong-code.pro</u>;
- 1.1.2. «Website Administration" authorized website management officers, acting on behalf of Alexander S. Filipenko, individual entrepreneur, being engaged in personal data processing organization as well as personal data processing purposes determination, personal data composition defining to be processed, actions (operations), performed with personal data;
- 1.1.3. «Personal data» any data, relating to either directly or indirectly having been determined or being determined individual (personal data subject);
- 1.1.4. «Personal data processing» implies any action (operation) or actions (operations) set, performed with personal data, including collection, recording, systematization, accumulation, storage, refinement (update, change), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, removal and destruction either with or without such automation tools use:
- 1.1.5. «Personal data confidentiality» the mandatory requirement to comply by the Website Administration or another person, who has obtained an access to personal data to prevent data distribution without the personal data owner's consent or other legal grounds availability;
- 1.1.6. «Website User (hereinafter referred to as the User)» a person, having got an access to the Website via the Internet and while using the Website;
- 1.1.7. Cookies a small data amount, sent by a web server and stored on the user's computer, which the web client or web browser sends to the web server each time in HTTP request, while trying to open the corresponding website page;
- 1.1.8. «IP-address» a unique node's network address in a computer network, built on IP protocol.

2. GENERAL PROVISIONS

4. PERSONAL INFORMATION COLLECTION PURPOSE

- 4.1. The User's personal data may be used by the Website Administration in order to:
- 4.1.1. Establish feedback with the User, including sending Website-related notifications and requests, services provision and User's requests processing;
- 4.1.2. User's location determination to ensure security and prevent fraud as well;
- 4.1.3. Personal data accuracy and completeness, provided by the User;
- 4.1.4. Newsletter and other information provision to the User with his consent on the Website behalf;

5. PERSONAL DATA PROCESSING METHODS AND TERMS

- 5.1. User's personal data processing is carried out time limit-free and legal way, including in personal data information systems while either using or without using such automation tools;
- 5.2. User's personal data may be transferred to the authorized bodies of state power of the Republic of Belarus on the grounds and in the manner, established by the Republic of Belarus;
- 5.3. The Website Administration informs the User about his personal data loss or disclosure, if any;
- 5.4. The Website Administration takes all the required organizational and technical measures in order to protect the User's personal data from unlawful or accidental access, destruction, alteration, blocking, copying, dissemination, as well as other illegal actions of third parties;
- 5.5. The Website Administration together with the User takes all required measures to prevent losses or other negative consequences, caused by the User's personal data loss or disclosure.

6. PARTIES' OBLIGATIONS

- 6.1. The User is obliged to:
- 6.1.1. Provide own personal data, required to use the current Website;
- 6.1.2. Update and supplement own personal data provided, in the event of any changes.

6.2. The Website Administration is obliged to:
6.2.1. Use the data obtained solely for the purposes, specified in clause 4 of the current Privacy Policy;
6.2.2. To keep the confidential data in a secret as well as avoid disclosure without the prior user's written permit, as well as avoid such data sale, exchange, publish, or disclose in any other possible way, except for clause 5.2. of the current Privacy Policy;
6.2.3. Take all the required precautionary measures to protect the User's personal data confidentiality in accordance with the procedure, used to protect such data type the existing business turnover;
6.2.4. Perform personal data blocking, relating to the relevant User, from the time of the User's request or his legal representative's or authorized body's request for the personal data subjects' rights protection for the verification period, in case of unreliable personal data or illegal actions detection.
7. PARTIES' RESPONSIBILITY7.1. The Website Administration, which failed to fulfill own obligations, is liable for losses, incurred by the User due to unlawful personal data use, in accordance with the legislation of the Republic of Belarus, except for as otherwise provided
for in the sections 5.2. and 7.2. of the current Privacy Policy; 7.2. The Website Administration is not responsible for the Confidential data loss or disclosure, if it:
7.2.1. Became public domain before its loss or disclosure;
7.2.2. Was received from a third party before it was received by the Website Administration;
7.2.3. It was disclosed with the User's consent.
8. DISPUTES SETTLEMENT
8.1. It's mandatory to file a claim (a written proposal for a voluntary dispute settlement) prior to filing a lawsuit in disputes, arising from the relationship between the Website User and the Website Administration.

- 8.2. The claim recipient notifies the claimant in writing of the claim consideration result within 30 calendar days from the claim recipient date.
- 8.3. The dispute will be submitted to the judicial authority in accordance with the current legislation of the Republic of Belarus in case of fail to reach the mutual agreement.
- 8.4. The current legislation of the Republic of Belarus applies to the current Privacy Policy and the relationship between the User and Website Administration.

9. ADDITIONAL TERMS

- 9.1. The Website Administration is entitled to make changes to the current Privacy Policy without the User's consent;
- 9.2. A new Privacy Policy takes effect from its posting date on the Website, unless otherwise provided by the new Privacy Policy version;
